Public Services – State and Subordinate Services – Prescription of minimum service for promotion/ appointment by transfer to next higher class, category of grade– Ad-hoc Rule – Issued.

ORDER:

In the G.O. 2nd read above, an ad hoc rule was made, providing that –

“Notwithstanding anything contained in the relevant Special Rules or the Ad hoc rules for the State and Subordinate Services, the minimum period of service wherever prescribed in the said rules for a member of a service from the lower category, class or grade, to the next higher category, class or grade, whether such appointment is made either by promotion in the regular line or by recruitment by transfer from any other service, that period shall be three years in the category, class or grade from which such promotion or transfer is made”.

2. Government, keeping in view the administrative exigencies and interests, made an ad hoc rule in the reference 3rd read above, reducing the minimum period of service for appointment by promotion or by transfer from three years to two years, for the panel year 2020-21.
3. Government, after careful examination of the matter, have decided that the minimum service for appointment by promotion or by transfer shall be reduced from three years to two years, without any panel year restriction, until further orders.
4. Accordingly, the following notification shall be published in the Telangana Gazette:

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Telangana hereby makes the following ad-hoc rule, which shall come into force with immediate effect and shall continue to be in force until any further provision is made in this regard.

AD-HOC RULE

“Notwithstanding anything contained in the relevant Special Rules governing the State and Subordinate Services and the Telangana State and Subordinate Services Rules, 1996, the minimum period of service wherever prescribed in the said rules for appointment of a member of a service from the lower category, class or grade, to the next higher category, class or grade, whether such appointment is made either by promotion in the regular line or by recruitment by transfer from any other service, shall be two years in the category, class or grade from which such promotion or transfer is made, as on the date of consideration (DPC)”.
