**ORDER:**

In the Government order 1<sup>st</sup> read above, orders were issued extending the revised Automatic Advancement Scheme in pursuance of the recommendations of Pay Revision Commission, 1986. Among other things, it has been ordered therein that the Category-III Teachers be allowed the pay scale of Rs.1330-2630 as special adhoc promotion post-II on completion of (22) years service.

In pursuance of agreement 2<sup>nd</sup> read above, and in partial modification of the orders issued in G.O. 1<sup>st</sup> read above, Government hereby order that the Category-III Teachers on completion of (22) years of service shall be allowed the scale of Rs.1550-3050 as Special Promotion Post-II scale subject to the condition that they are qualified to hold the post of Head Master of Secondary School. The qualifications prescribed for Head Master in the Service Rules are as under:

- i) A Bachelor's Degree in any subject and a B.Ed Degree from a University in India established or incorporated by or under the Central Act and State Act or a provincial Act or an Institution recognized by the University Grants Commission or an equivalent qualification.

Provided that in respect of Teachers appointed prior to 14-07-1983 and not holding the above qualification, they must pass the P.A.T. prescribed in G.O.Ms.No.320 Edn., Department, Dt.10-08-1983 read with G.O.Ms.No.166, Education Department., Dt.09-03-1984 and

- ii) Must have passed:
  - a) Deputy Inspectors Test.
  - b) Accounts Test for Subordinate Officers Part-I. Provided that those who passed the Head Masters Accounts Test and who crossed 45 years of age prior to 20-06-1983 need not pass the above test. Provided that the above conditions viz(i)&(ii) do not apply to the Teachers who retired / died before 30-06-1991.

The Special Promotion Post-II Scale as indicated above shall be admissible with effect from 01-07-1986 or from the date of completion of 22 years of service and acquisition of qualifications mentioned above whichever is later.

The Special Adhoc Promotion Post-II Scale of Rs.1330-2630 shall stand abolished with effect from 01-07-1986. However the incumbent who are not qualified for Special Promotion Post –II scale and who are not qualified for Special Promotion Post-II scale and who are drawing pay in the scale of Rs.1330-2630 as on the date of issue of these orders shall continue to draw pay in the said scale, as personal to them, till they qualify for Special Promotion Post-II scale.

Consequently the pay of such of those teachers under Category-III, who have completed 22 years of service and qualified to hold the post of Head Master of Category-I as per the qualifications laid down in Para-I above by 01-07-1986 shall be fixed under F.R.22(b)(i) read with F.R.31(2) in the scale of Rs.1550-3050, based on the pay drawn in the Special Promotion Post-I scale of Rs.1280-2440 on 01-07-1986 and his pay will be regulated from time to time in the said scale. The monetary benefit arising out of the above fixation shall be allowed from 01-04-1993.

In respect of Teaches belonging to Category-III who have completed 22 years of service on or after 01-07-1986 holding Special Adhoc Promotion Post-II scale of Rs.1330-2630 as per the orders in force and who have qualified to hold the post of Special Promotion Post-II scale of Rs.1550-3050 subsequent to 01-07-1986 their pay shall be fixed under F.R22(a)(ii) based on they pay drawn in the scale of Rs.1330-2630 as these employees have already derived the benefit of pay fixation on appointment to Special Adhoc Promotion Post-II scale. Their date of next increment would accure on the date on which they would have drawn their increment but for appointment to the Special Promotion Post-II scale.

In respect of persons who have completed 22 years of service and qualified to the Special Promotion Post-II scales subsequent to 01-07-1986 their pay shall be fixed under FR22(a)(i) read with FR31(2) based on the pay drawn in the Special Promotion Post-I scale of Rs.1280-2440 from the date of appointment to Special Promotion Post-II scale with monetary benefit from 01-04-1993, since these teachers have been drawing pay in the Special Adhoc Promotion Post-II scale of Rs.1330-2630 by virtue of order 1<sup>st</sup> read above, there shall be no payment of arrears nor there shall be recovery till 31-03-1993.

The monetary benefit arising out of those orders shall be with effect from 01-04-1993 and the amounts drawn already in the scale of Rs.1330-2630 till 31-03-1993 need no be recovered.

These orders are applicable to Category-III Teachers of all managements, namely Government, Panchayat Raj Bodies, Municipalities, Municipal Corporations and Aided Schools.

The orders are issued in the G.O.1<sup>st</sup> read above shall stand modified to this extent.
