**ORDER:**

In the G.O. first read above, orders were issued introducing a new Rule viz., FR 22-B, which contemplated fixation of pay of a Government employee when promoted or appointed to a higher post. Those orders were effective from 23<sup>rd</sup> August'1983.

2. In the G.O. second read above, orders were issued extending the benefit envisaged in the G.O. first read above, from a retrospective date that is from 25-12-1982, with monetary benefit from 23-08-1983.

3. In the G.O. 3<sup>rd</sup> read above, orders were issued removing the pay limit and allowed the benefit of FR.22-B to all the employees when promoted or appointed to a higher post carrying duties and responsibilities of greater importance than those attached to the post held by him in the previous post.

4. The Pay Revision Commissioner, 1993, among other things, recommended for the continuance of the Automatic Advancement Scheme, introduced in G.O.Ms.No.117 Finance & Planning (FR.PRC.I) Department, Dt.25-05-1981 and amended from time to time, with certain modifications. Basing on the said recommendations, in the G.O. fourth read above, orders were issued, governing the Revised Automatic Advancement Scheme with effect from 01-08-1993, with a stipulation that the fixation of pay of an employee who is holding Special Grade/ Special Promotion Post when he is promoted to the post under Service Rules, shall be made under FR.22(a)(i), in modification of the orders issued in G.O.(P) No.2, Fin. & Plg. (FW.PRC.I) Dept., Dt.04-01-1988.

It has therefore become necessary to amend rule 22-B of the Fundamental Rules and Rule 35-A of the Hyderabad Civil Services Rules suitably, so as to be in conformity with the orders issued in the G.O. fourth read above.

### **NOTIFICATION – I**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the governor of Andhra Pradesh hereby makes the following amendment to the Fundamental Rules.

2. The amendment hereby made shall be deemed to have come into force with effect on and from 01-08-1993.

### **AMENDMENT**

In the said rules, to rule 22-B, after the fourth proviso, the following proviso shall be added, namely:-

“Provided also that where a Government servant who is holding special Grade Post/Special Promotion Post-I/Spl. Adhoc Promotion Post is promoted or appointed to next higher post carrying duties and responsibilities of greater importance than those attaching to the post held by him, his pay in the time scale of higher post shall be fixed in terms of FR 22(a)(i) only but not under this rule”.

### **NOTIFICATION – II**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following amendment to the Hyderabad Civil Services Rules.

2. The amendment hereby made shall be deemed to have come into force with effect on and from 01-08-1993.

### **AMENDMENT**

In the said rules, to rule 35-A, after the fourth proviso, the following proviso shall be added, namely:-

“Provided also that where a Government Servant who is holding Special Grade Post/Spl. Promotion Post-I/Spl. Adhoc Promotion Post, is promoted or appointed to next higher post carrying duties and responsibilities of greater importance than those attaching to the post held by him, his pay in the time scale of higher ost shall be fixed in terms of rule 34 (a)(i) only but not under this rules”.
