### **ORDER:**

In the G.O. 1<sup>st</sup> read above, orders have been issued revising the pay scales of the State Govt. Employees based on the recommendations of Pay Revision Commissioner, 1993 with effect from 01-01-1993 with monetary benefit from 01-04-1993. Subsequently in the G.O. 7<sup>th</sup> read above, the Revised Pay Scales were given effect from 01-07-1992 with monetary benefit from 01-04-1993. According to the above orders the Revised Pay Scales of Special Grade / Special Promotion Post / Special Adhoc Promotion Post in respect of those who are already enjoying the benefit of Automatic Advancement Scheme shall be determined based on the Revised Pay Scales of the original post and once the revised scale of Automatic Advancement Grades are determined, the pay shall be fixed in the Revised Pay Scales on the basis of the actual pay drawn in the Automatic Advancement Scale of the existing grades. In the G.O. 2<sup>nd</sup> read above, orders were issued for the implementation of Automatic Advancement Scheme as per the recommendations of Pay Revision Commissioner. Similarly in the G.O.3<sup>rd</sup> read above, orders were issued for the implementation of Automatic Advancement Scheme in respect of Teachers. In the G.O.6<sup>th</sup> read above, orders were issued implementing Automatic Advancement Scheme in respect of Junior Lecturers and Physical Directors in Junior Colleges. In the G.O. 5<sup>th</sup> read above, orders were issued implementing Automatic Advancement Scheme to Non-Teaching Staff of Universities.

2. It has been brought to the notice of the Government that in some cases the pay fixed in the Special Grade Scales of Revised pay Scales, 1993 is equal/less than the pay fixed in the Ordinary Grade Scales.

3. Government, after careful consideration, hereby order that where the pay of a Govt. Employee in the Special Grade Scales as fixed in the Revised Pay Scales, 1993 is equal or less than the fixed in the Ordinary Grade Scale in the Revised Pay Scales, 1993 his pay in the higher post shall be fixed at the stage next above the pay fixed in the Ordinary Grade Scale on the analogy of Rule 6(g)(i) of the A.P. Revised Scales of Pay Rules, 1993. The pay on the date of next increment in the Ordinary Grade in the Revised Pay Scales, 1993 shall be regulated under F.R. 31 (2). An illustration is given in the Annexure to this order for guidance.

4. These orders will take effect from 01-07-1992.
