## ORDER:

In the Government Order  $1^{st}$  read above, orders were issued implementing the revised pay scales, 2005 with effect from 1-7-2003 with monetary benefit from 1-4-2005.

2. The Government based on the agreement with the Joint Action Committee of Employees, Teachers and Workers and A.P. Secretariat Employees Coordination Committee, among other issues, Government have agreed to appoint a Committee for resolution of certain further demands raised by the Joint Action Committee.

3. The Government accordingly, appointed Sri N. Rangachary, Advisor to Government, Finance Department, as Chairman, One Man Committee in the G.O. 3<sup>rd</sup> read above with the terms of reference as laid down therein.

4. The One Man Committee submitted its report to the Government. The Government after careful examination of the report, decided to implement the following recommendations of the One Man Committee in the G.O.4<sup>th</sup> read above, among which one of the recommendations was for revising the rates of CCA in respect of twin cities as indicated below from the date of issue of orders.

Below Rs.4825/-	85	100
Rs.4825 to Rs.7769/-	120	150
Rs.7770 to Rs.10564/-	180	200
Rs.10565 and above	275	300

5. The Government in the 5<sup>th</sup> read above issued order implementing the revised Master Scale recommended by One Man Committee and revising the pay scales with effect from 1-7-2003 with monetary benefit from 1-4-2005.

6. The Government accordingly hereby sanction the revised rates of City Compensatory Allowance to the employees in different pay ranges in the Revised Pay Scales of 2005 as indicated below as far as Hyderabad/ Secunderabad concerned:
