Professional Tax – Recovery of professional tax amount due to Government from Non-Gazetted Employees (NGOs) – Further Orders – Issued.

ORDER:

In the G.O 1st read above Government issued orders for implementation of revised pay scales to all State Government employees w.e.f.1.7.2003 with monetary effect from 1.4.2005, and ordered therein that the arrears of salary in RPS 2005 from 1.4.2005 to 31.7.2005 shall be credited to GPF accounts of the employees.

2. In the G.O. 2^{nd} read above Government ordered that crediting of the arrears of RPS 2005 for the period 1.4.2005 to 31.7.2005 into GPF accounts, shall be kept in abeyance in respect of Non-Gazetted Officers (NGOs) till further orders. Government further issued orders in G.O.3rd read above stating that 65% of profession tax arrears due from NGOs will continue to be in abeyance and 35% of profession tax arrears due to Government from NGOs will be adjusted against the PRC 2005 arrears payable to NGOs.

3 In the reference 4th^h read above, the DTA sought clarification on recovery procedure to be followed with regard to the employees who retired or died in between 01-08-1996 and 31.07.2005.

4. Government, after careful consideration, hereby issue the following orders:

(i) Recovery of the Professional Tax arrears in respect of the employees who **retired** between 01.08.1996 and 31.07.2005 shall be effected from the terminal benefits/pension payable to retired employees in 10 easy installments on the analogy of serving employees i.e., recovery of 65% of professional tax arrears shall be kept in abeyance and 35% of the professional tax arrears to be recovered; and

(ii) Professional Tax arrears in respect of the employees who **died** between 01.08.1996 and 31.07.2005 shall be waived.

All the HODs/DTA/PAO/Pension Payment Officers shall take necessary action to implement the above orders immediately.
