ORDER:-

The Andhra Pradesh General Subordinate Service Rules, 1995 made in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, vide G.O first read above, were in force as on 01.06.2014. In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organization Act, 2014, orders were issued vide reference 2 read above, adopting the Andhra Pradesh General Subordinate Service Rules, 1995 with the amendments issued thereto from time to time to the State of Telangana.

2. Subsequently, orders were issued in the reference 3rd read above, changing the nomenclature of Assistant (DR&T) as Section Assistant Grade-II, Category-I of class (A) in Telangana General Subordinate Service Rules, since there are no additional financial implications.
