**ORDER:**

Keeping in view the difficulties being faced by the Class-III and Class-IV employees of the Secretariat and HoDs who are local to TS, opted to TS and allotted to AP, and also 13 eligible Class-IV employees who are appointed on compassionate grounds in Andhra Pradesh, the Government of AP conveyed its agreement in principle in the references 1<sup>st</sup> and 2<sup>nd</sup> read above, for relieving these employees as and when the Government of Telangana places a formal request either on a permanent basis or on deputation.

2. In response to the above, the Government of Telangana have informed through the reference 3<sup>rd</sup> & 4<sup>th</sup> read above, that the Government of Telangana has decided to bring back Telangana local class III and Class IV employees who are allotted to Andhra Pradesh against their options during the final allocation of State cadre employees by the Kamalanathan Committee.

3. While enclosing a list of employees of Class-III & Class-IV categories who are allotted to Andhra Pradesh in the final allocation and working in Government of Andhra Pradesh, the Government of Telangana have informed that the list is prepared based on available information and that the Government of Telangana is willing to take back all employees of Class-III & Class-IV who are locals to Telangana and allotted to Andhra Pradesh against their options and therefore requested to relieve the employees who are willing to give an undertaking to join wherever they are posted in Telangana and take last rank in the respective cadres working in Telangana, in the proforma (Annexure-I). In regard to the 13 eligible class IV employees appointed on Compassionate grounds, whose names were sent to Government of TS in the reference 2<sup>nd</sup> read above, the Principal Secretary to Government, General Administration (SR-GC) Department, Telangana clarified that their names may also be included in the list of TS local employees working in AP to be taken back to TS.

4. In the above circumstances, the Government have decided to relieve all the TS local employees of Class-III & Class-IV categories, as well as the 13 eligible Class-IV employees who are appointed on compassionate grounds, who give undertaking in the proforma furnished by Government of Telangana.

5. The Department-wise list of Class-III & Class-IV employees working in the Secretariat Departments has been prepared based on the final allocation orders issued by GoI and is enclosed as Annexure-II to this G.O. However, there may be certain employees who are now working in the Departments other than the Departments indicated in the enclosed list on account of their transfer/ promotion. The G.A.(Estt.III) Department are therefore, requested to first thoroughly scrutinize the list of Class-III and Class-IV employees, including the employees appointed on compassionate grounds, pertaining to Departments of Secretariat and identify the employees who are now working in the Departments other than the Departments indicated against their names in the list. The names of such employees may be included under the Department in which they are presently working and communicate the list to the Departments concerned with necessary instructions to relieve them, after obtaining the undertaking from them in the proforma furnished by the Government of Telangana, duly following the procedure, with directions to report to the Prl. Secretary to Government (SR), GA(SR-GC) Dept., in Telangana State. The undertaking in the prescribed proforma may be obtained in duplicate and one copy retained with the Department and the other enclosed to the relieving orders issued to them.

6. Similarly, the Department-wise list of Class-III & Class-IV employees working in the HoDs has been prepared based on the final allocation orders issued by GoI and is enclosed as Annexure-III to this G.O. However, there may be certain employees who are promoted to the next category. The Secretariat Departments noted in the address entry are, therefore, requested to get the list of Class-III and Class-IV employees enclosed herewith thoroughly scrutinized by the HoDs concerned under their administrative control and issue necessary instructions to them to relieve the employees whose names are included in the list, after obtaining undertaking from them in the proforma furnished by the Government of Telangana duly following the procedure, with instructions to report to the Prl. Secretary to Government (SR), GA(SR-GC) Dept., in Telangana State. The undertaking in the prescribed proforma may be obtained by the HoDs concerned in duplicate and one copy retained with the HoD and the other enclosed to the relieving orders issued to them.

7. Copy of the orders issued may invariably be marked to General Administration (SR) Department for record.
