ORDER:-

In the reference 1st read above, Government have issued orders for implementation of the Revised Pay Scales-2020 for the State Government Employees wherein it is ordered for implementation of the Revised Pay Scales, of 2020, which come into force on and from 01.07.2018. The monetary benefit shall be allowed from 01.04.2020. Further ordered that in respect of employees of Public Sector undertakings, Corporations, Co-op Societies and other such institutions under the Government, that the concerned administrative department shall obtain specific orders of the competent authority in consultation of Public Enterprises and Finance (HRM.IV) Dept., duly following the Business Rules, in respect of each such entity.

2. The VC & Managing Director, TSEWIDC, Hyderabad in the reference 2nd read above, has requested to issue orders for implementing the PRC, 2020 to the employees of TSEWIDC w.e.f. 01.07.2018

3. After careful consideration, Government hereby accept the proposal of VC & Managing Director, TSEWIDC, Hyderabad for extending Revised Pay Scales, 2020 to the (221) regular employees of Telangana State Education & Welfare Infrastructure Development Corporation (TSEWIDC), in terms of G.O.Ms.No.51, Finance (HRM.IV) Department, dated.11.06.2021 subject to approval of Management Committee of the TSEWIDC, Hyderabad

4. The Revised Pay Scales, 2020 shall be deemed to have come into force on and from 01.07.2018, the monetary benefit shall be allowed from 01.04.2020. The arrears for the period from 01.04.2020 to 31.03.2021 shall be paid at the time of superannuation of the Government employee or to the legal heirs in case of demise of the employee. The arrears for the period from 01.04.2021 to 31.05.2021, will be paid during the financial year 2021-22. The salary in the Revised Pay Scales, 2020 will be paid from the month of June, 2021 payable in July, 2021.

5. The VC & Managing Director, TSEWIDC, Hyderabad should follow all the Orders issued by the Government in the matter from time to time in addition to these Orders issued.

6. This order issues with the concurrence of Finance (HRM.IV) Dept., vide their U.O.No.1173716/106/A1/HRM.IV/2021, dated 25.08.2021.
