Accordingly, Government hereby direct that, no furniture shall be allowed to be purchased by Government Departments / Offices, except Hospitals, Hostels, Residential Schools, Residential Colleges, Newly Created Offices, Colleges, Constitutional Authorities i.e. Governor Secretariat, High Court of A.P. for a further period up to 31-03-2008.
