ORDER:

In the Government Order first read above, based on the recommendations of Pay Revision Commission, 1999 orders were issued sanctioning Fixed Travelling Allowance to Government Servants who were in receipt of the same as indicated therein.

- 2. Based on the recommendations of Pay Revision Commission, 2005, orders were issued implementing the Revised Pay Scales of 2005, to the State Government Employees in Government Order second read above. The Pay Revision Commission, 2005, among others, has reviewed the existing pattern and recommended for enhancement of Fixed Travelling Allowance rates.
- 3. Government, accordingly, hereby order that the Fixed Travelling Allowance shall be payable as indicated below to the Government Servants who were in receipt of Fixed Travelling Allowance immediately prior to this order.

- 5. The existing Andhra Pradesh Civil Services (Travelling Allowance) Rules, 1996 and orders issued from time to time shall continue to apply except as provided for in this order.
- 6. The Revised Rates prescribed in this Order will be effective from the date of issue of the order.
- 7. Necessary amendments to the Andhra Pradesh Civil Services (Travelling Allowance) Rules, 1996 shall be issued in due course.
