In the Government Order first read above, basing on the recommendations of Pay Revision Commission, 2005, orders were issued revising the Travelling Allowance and Daily Allowance on tour.

2. In the Government Orders second read above, basing on the recommendations of the One Man Committee, orders were issued revising the Master Scale and segments thereof w.e.f., 01-07-2003 with monetary benefit from 01-04-2005.

3. Consequent on the revision of the Master Scale to the State Government employees vide reference 2<sup>nd</sup> read above, the Government after careful examination hereby issue amendment order to the Government orders 1<sup>st</sup> read above.
