ORDER:

In the Government Order first read above, orders were issued sanctioning a remuneration of Rs.740/- per month, being the minimum of time scale of Rs.740-1150 assigned to the last grade services in Revised Pay Scales, 1986, to the Full Time Contingent Employees and allowed DA, HRA and CCA thereon from time to time on par with Government Employees.

2. In the Government Order second read above, Pay Revision Commission was constituted and Sri J. Rambabu, IAS., (Retd.) appointed as Pay Revision Commissioner and the terms of reference of the Pay Revision Commissioner were laid down in the G.O 3rd read above.

3. Pay Revision Commission submitted its report to Government on 30-6-2005 and Government have accepted the same with some modifications.

4. In the Government Order 4th read above, revised pay scales have been implemented with effect from **1-7-2003** with monetary benefit from **1-4-2005** and arrears from **1-4-2005 to 31-7-2005** credited to the GPF accounts of the respective employees.

5. The Pay Revision Commission, 2005 also recommended for the revision of the remuneration to the Full Time Contingent Employees as follows:

"The remuneration is fixed at Rs.740/- per month in addition to DA, HRA and CCA applicable in 1989 on the basis that starting salary of the last grade employees was Rs.740/- at that particular point of time. These employees are not eligible to be converted into last grade service and given scale. It is fair and proper to apply the principle adopted in 1989 by giving a remuneration of the starting salary of the lowest scale in the revised scale now recommended by the Commission. They may be paid HRA, DA and CCA as applicable. The Commission recommends minimum of the lower pay scale now recommended by the commission i.e. Rs.3850/- p.m."

6. The Government have accepted the above recommendation of the Pay Revision Commission and hereby order for the revision of Remuneration from Rs.740/- per month to **Rs.3850/-** per month, being the minimum of the Time Scale of Rs.3850-8600 assigned to last grade services in Revised Pay Scales, 2005 to the Full Time Contingent Employees and also allow DA, HRA and CCA on the remuneration of Rs.3850/- on par with Government Employees as ordered in G.Os 5th, 6th and 7th read above. These orders shall be made applicable to the Full Time Contingent Employees who are drawing remuneration in Revised Pay Scales, 1986 at Rs.740/- only and shall be given effect from **1-4-2005** and arrears shall be paid in cash, as this category of employees have no General Provident Fund Accounts, after adjusting the amounts already paid as per the existing orders.

7. This orders issues with the concurrence of Finance (PC-I) Department, vide their U.O.No.25433-A/625/A1/PC-I/2005, Dated 23-9-2005.
