**ORDER:**

An agreement was reached between the Government of Andhra Pradesh and the Telangana Joint Action Committee of Employees, Teachers and Workers on 04.03.2011. The item 5 in the agreement is as follows:-

"Fair Share Principle will be strictly followed in all appointments made through deputation/appointments by transfer in offices of Heads of Departments, State Level Institutions, Special Offices, Major Development Projects and Secretariat (12½)."

2. Previously instructions were issued in {Para 2 (A-1)} of orders issued vide reference 1<sup>st</sup> read above in relation to applicability of Fair Share Principle.
3. Government hereby further order that Fair Share Principle shall be strictly followed in all appointments made to the Departments of Secretariat, Offices of the Heads of Departments, Special Offices or Establishments, State Level Offices or Institutions and Major Development Projects (as prescribed under Para 14) of the Andhra Pradesh Public Employment [Organisation of Local Cadres and Regulation of Direct Recruitment] Order, 1975, through deputations / appointment by transfer.
4. The Administrative Departments in the Secretariat shall issue further instructions to this effect to all Heads of Departments and Special Offices / State Level Institutions / Major Development Projects.
