ORDER:

Finance (Admin.II) Department has stated that in the reference first read  
above the Director of State Audit has requested the Government for creation of  
one (1) post of Additional Director and three (3) posts of Joint Directors by  
abolishing four posts of Deputy Director. Further the Director of State Audit has  
stated that the post of Additional Director and Joint Director are required for  
improving the efficiency of the department. The post of Additional Director and  
one Post of Joint Director will be deployed in Head Office and one Joint Director  
will be positioned in the Institute of Dr.MCR HRD and one Joint Director will be  
in-charge of Audit of TTD.

2. In the U.O. second read above, the Finance (Admn.II) Department has  
proposed for creation of one (1) post of Additional Director by upgrading one post  
of Deputy Director and for upgradation of three (3) posts of Deputy Directors to  
that of Joint Directors in the State Audit Department.

3. Government, after careful examination of the proposal, hereby accord  
sanction for creation of one (1) post of Additional Director in the scale of pay of  
Rs.31550 – 53060 and three (3) posts of Joint Director in the scale of pay of  
Rs.27000 – 51760 in the State Audit Department. Consequently four posts of  
Deputy Director in that department stand abolished.

4. The Finance (Admin.II) Department shall take further necessary action in  
the matter accordingly.
