Orders were issued in the reference fourth read above imposing ban on all transfers pertaining to Government employees upto the end of April, 2005 except in respect of the transfers which are inevitable on account of disbandment of posts, reversions, retirements, promotions, repatriations, deputations (on foreign service only) and disciplinary proceedings and advised the Principal Secretary / Secretary of the administrative department to circulate the files through Finance (W&M) Department, Minister of the administrative department, Minister Finance and Chief Minister and obtain exemption orders even in the cases referred above. These orders were extended until further orders vide reference fifth cited. Further orders were issued in the reference sixth cited lifting the ban on transfers w.e.f. 15.6.2005 to 30.6.2005. In the reference seventh cited orders were issued with regard to posting of the employees consequent on their promotion to the clear existing vacancy.

2. It is here by further clarified that in respect of the employees who are required to be given posting orders due to disbandment of posts, reversions, repatriations, deputations (on foreign service only), disciplinary proceedings and returning from long leave of more than 3 months, the procedure indicated above need not be followed, if the employees are considered for posting in a clear existing vacancy without shifting any another employee.

3. If the Department proposes to issue posting orders otherwise i.e. by shifting other employee, then the department have to follow the procedure indicated at para 1 ante, as it attracts ban on transfers.

4. The Treasury Officers shall admit the salary bill of the employees referred at para 1 ante if the transfers are effected as per the clarification at para 2 ante.

5. All the Departments of Secretariat and Heads of Department shall follow the procedure accordingly.
