ALLOWANCES – Revision of Pay Scales – Recommendations of Pay Revision Commission, 2010 on Machine Allowance to the Copyists in the Judicial Department where Government have not supplied Computers / Photo Copying Machine - Orders -Issued.

ORDER:

Government have issued orders in the reference first read above, enhancing the Machine allowance to the Copyists of the Judicial Department where Government have not supplied Typewriters, from Rs.75/- to Rs.100/- per month based on the recommendation of the Pay Revision Commission, 2005.

2. In the Government order second read above, based on the recommendations of Pay Revision Commission, 2010 orders were issued for implementing the Revised Pay Scales, 2010 to the State Government employees.

3. The Pay Revision Commission, 2010 recommended to continue Machine allowance at the same rate of Rs.100/- per month to the Copyists in the Judicial Department where Government have not supplied Computers / Photo Copying Machines to them and it shall cease from the day on which Computers / Photo Copying Machine are provided by Government.

4. Government accepted the recommendations of the Pay Revision Commission, 2010 and hereby order to continue the Machine Allowance at the same rate of Rs.100/- per month to the Copyists in the Judicial Department where Government have not supplied Typewriter / Computers / Photo Copying Machine to them. It is also ordered that this allowance shall cease from the day on which the Typewriter / Computer / Photo Copying Machine is provided by Government.

5. These orders shall come into force with effect from 01.04.2010.

6. Necessary amendments to the Andhra Pradesh Manual of Special Pays and Allowances will be issued separately.
