2. Departments can choose any of the three CUGs mentioned above. Any GoAP connection if existing on higher tariff plans, they should try to migrate to any one of the above three CUGs to take advantage of the lower tariff.

3. If any other telecom operators comes forward to match the tariff indicated in para 2 above, such cases will be considered separately. Such cases, if any, will be clubbed together and may be taken up for consideration after six months.

4. This G.O. would be valid for one year with effect from 16.08.2008.

5. This order does not require the concurrence of Finance Department.
