ORDER:

Government in the reference read above, basing on the recommendations of Pay Revision Commission 2005, revised the pay scales of the State government employees with effect from 01-07-2003 with monetary benefit from 01-04-2005.

2. Further it has come to the notice of the Government that legal heirs of deceased employees, who died while in service on or after 1st July, 2003 and who expired before the last date for the exercise of option under sub-rule(2) of Rule 5 of the A.P. Revised Scales of Pay Rules, 2005 are not in a position to exercise the option in the absence of a specific provision in the said rules.

3. Government after careful consideration hereby order that the legal heirs of the deceased employees, who died while in service on or after 1st July 2003 and who expired before the last date for the exercise of option, may also be permitted to exercise option for the Revised Pay Scales, 2005.

4. These orders shall be deemed to have come into force with effect from 01-07-2003 with monetary benefit from 01-04-2005.

NOTIFICATION

In exercise of the powers conferred by the proviso to Articles 309 of the constitution of India, the Governor of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Revised Scales of Pay Rules, 2005 issued in G.O.(P).No.213 Fin. (PC.I) Dept., Dt.27-08-2005

The amendment hereby made shall be deemed to have come into force on the 1st July 2003, but the monetary benefit shall accrue with effect on and from the 1st April 2005.

AMENDMENT

- (8) A Government employee who retired on or after the 1st July 2003 but before the date of publication of these rules in the Andhra Pradesh Gazettee may exercise option under this rule within a period of six months from the date of receipt of the communication in that behalf by him from the Head of Department or Office in which he was employed.
- (9) In the case of a Government employee who died while in service on or after the 1st July'2003 or who expired before the last date for the exercise of option under sub rule(2) his legal heirs may exercise option in the manner set out in sub rule(8) of this rule.”
