ORDER:

In the Government order first read above, based on the recommendations of the Pay Revision Commission, 2005, orders were issued revising the Pay scales of the State Government employees and Local bodies, with effect from 1-7-2003 with monetary benefit from 1.4.2005.

- 2. In the Government Order 2_{nd} read above, based on the recommendations of One Man Committee, orders were issued revising the Master scale and segments thereof with effect from 1-7-2003 with monetary benefit from 1.4.2005.
- 3. In the letters 4^{th} read above, it was brought to the notice of the Government that the posts of Supervisors (4) and Workers (3) held by redeployed employees of the erstwhile Hyderabad Allwyn Limited who are working in Town and Country Planning Department were not brought to the notice of the Pay Revision Commission, 2005 and they were not included in the respective Departmental Schedule of Revised Pay Scales, 2005 appended to Government Order 1^{st} read above as amended in the G.O 2_{nd} read above, as a result of which, these categories were not allowed Revised Pay Scales, 2005. Therefore it was requested to issue necessary amendment to the Departmental Schedule of the respective Department by including the posts held by the redeployed employees of the erstwhile Hyderabad Allwyn Limited who are working in the above department.
- 4. Government examined the matter and after careful consideration decided to include the posts held by the redeployed employees of the erstwhile Hyderabad Allwyn limited in the Town and Country Planning Department under the heading of Departmental Schedule under Schedule-II of the Revised Pay Scales, 2005 by amending the said Schedule-II.
