ORDER:

In the Government Order 2nd read above, orders Were issued sanctioning the City Compensatory Allowance at 6% of pay subject to a maximum of Rs. 75/- per month to all the employees Working in the twin cities of Hyderabad and Secunderabad. In the Government Orders 3rd and 4th read above, Orders Were issued sanctioning City Compensatory Allowance at the rate of 3.5% of pay subject to a maximum of Rs. 10/-per month with marginal adjustment upto Rs. 1065/- such that pay plus City Compensatory Allowance does not exceed Rs. 1074/- to the employees Working in Visakhapatnam and Vijayawada consequent on declaration of these towns as D-2 Class Cities by the Government of India.

2. The pay Revision Commissioner 1986 has recommended the adoption of rates and norms recommended by the central pay Commission. The Government have examined the recommendation of the Revision 'Commissioner and sanction the following revised rates of city Compensatory Allowance to the employees in different pay ranges in the Revised Pay Scales of 1986 as follows:

Note: Pay for the purpose of these orders shall be pay as defined in FR 9(21)(a).

3. Government also hereby order that in respect of employees drawing pay in the A.P. Revised pay Scales, 1976 the pay means the pay plus D.A. at 320 points which was

treated pay for the purpose of claiming City Compensatory Allowance in G.o.Ms.No.89, Finance and planning Department, dt. 10-3-1983.

4. The City Compensatory Allowance at the above shall be admissible to all categories of personal i.e., Government employees, Teaching and Non-teaching staff of the Government Colleges, Zilla Parishads, Panchayat samithis and Municipalities, all other employees of Gram .panchayats, Panchayat samithis. Municipalities, Zilla parishads and Zilla Grandhalaya Samsthas, Agricultural Market Committees, Work charged establishment who get monthly pay in regular pay scales and full time contingent employees on monthly wages.

5. The city compensatory Allowance shall be admissible to those employees whose offices and institutions are situated outside the limits of the Municipal corporation of Hyderabad, Visakhapatnam and Vijayawada provided the distance between the place of duty and the periphery of the municipal limits of Hyderabad, Visakhapatnam and Vijayawada does not exceed 8 K.Ms.

6. These orders shall come into force with effect from 1st July, 1986.
