ORDER:

The pay Revision Commissioner, 1986 in his report (Volume I) has stated that the rates of Fixed Traveling Allowance are varying from Department to Department and notwithstanding the fact that the minimum days of tour prescribes is the same and the level of the officers is also the same and for the purpose of payment of Fixed Traveling Allowance the area of operation should be the main criteria. While marginal differences may be prescribed, pay scales as the basis for fixation should only be secondary consideration. He has recommended the following taking into consideration the tour charges and travel expenses one is expected to incur during such tours: -

The Pay Revision Commissioner, 1986 has further recommended that these having jurisdiction of more than a Revenue Division should be brought under Mileage Traveling Allowance

The recommendation of Pay Revision Commissioner, 1986 has been accepted by the Government. The Government after careful consideration here by order that Fixed Traveling Allowance as mentioned below shall be sanctioned subject to furnishing the information required in the annexure to this order in triplicate to the Treasury officer/Pay and Accounts Officer and in the case of Officers having jurisdiction of more than a Revenue Division they will be eligible to mileage traveling allowance: -

The Secretaries to Government or Heads of Departments are permitted to fix the Fixed Traveling Allowance as per the above norms. The draft order will come into force with effect from the date of issue of this order.
