ORDER:

In the Government Orders 1st to 4th read above Government have sanctioned advance increments as recommended by the Pay Revision Commissioner, 1974 and Pay Revision Commissioner, 1978 respectively and the advance increments have not been sanctioned to the Government employees who have acquired the additional qualifications at the cost of the Government.

- 2. The Pay Revision Commissioner, 1986 among other things recommended for sanction of advance increments in respect of the employees who have acquired additional qualifications at the cost of Government also. Accordingly orders were issued in the Govt. Order 5th read above. The Joint Council of Associations and Unions has represented to sanction the advance increments in 1974 and 1978 pay scales also in respect of employees who acquired additional qualification at the cost of the Government also.
- 3. After careful consideration, Government have agreed to sanction advance increments in 1974 and 1978 pay scales in respect of employees who acquired higher qualifications at the cost of the Government and accordingly hereby order that the Government employees who have acquired additional qualifications between the period from 1-4-1977 to 30-6-1986 at the cost of the Government be sanctioned advance increments at the rates sanctioned during the above period in the orders issued from time to time, however subject to the following conditions:
- (1)| The rate of advance increments shall be the same as prevalent on the date 'of acquisition of qualification (and not as per the rate in 1986 scales).
 - (2) The monetary benefit of such advance increments shall be from 1-7-1986.

The condition that the advance increments are not admissible for the employees who acquired additional qualifications stipulated in the Govt. orders issued from time to time shall be deemed to have been withdrawn.
