The Telangana Public Employment (Regulation of Age of Superannuation) Act, 1984 was amended by Telangana Act No.3 of 2021, enhancing the age of superannuation of all State Government Employees from 58/60 years to 61 years. This amendment has come into force w.e.f. 30<sup>th</sup> March, 2021.

**2.** Several grant-in-aid Institutions, Societies, Universities (in respect of non-teaching staff), Corporations, Institutions and other Organizations under Government, have earlier adopted the age of superannuation as prescribed for the State Government Employees in the service rules for their employees also, with the approval of the competent authority in respect of their organizations.

**3.** Consequent on the amendment to the Telangana Public Employment (Regulation of Age of Superannuation) Act, 1984, enhancing the age of superannuation of State Government employees from 58/60 years to 61 years, all the Grant-in-aid Institutions, Societies, Universities (in respect of non-teaching staff), Corporations, Institutions and other Organizations may take necessary action to adopt the age of superannuation as enhanced for the State Government employees, for their employees also from the date the amendment to the Telangana Act No 3 of 2021 come into force i.e., 30<sup>th</sup> March, 2021, duly obtaining the approval / ratification of the competent authority and amending the relevant service rules of their respective organizations.

**4.** All the Secretaries and Heads of Departments concerned are requested to take necessary further action in the matter in respect of the above institutions and organizations under their administrative control, accordingly.

**5.** All Secretaries to Government are further requested to inform the action taken in this regard, in a consolidated form in the proforma annexed in respect of all the institutions and organizations under their administrative control, to Finance (HRM-III) Department.
