**ORDER:**

In the references 1<sup>st</sup> and 2<sup>nd</sup> read above, the Accountant General, Andhra Pradesh, Hyderabad has suggested to enhance the validity period of the Gratuity Payment Order (G.P.O.) from 6 months to 3 years in order to avoid hardship to the pensioners in particular and to avoid legal complications.

2. As per Sub Rules (c) under TR.16 of A.P. Treasury Code, if a Gratuity remains un-drawn for more than six months, the payment order shall be returned to the Accountant General, mentioning the cause known, of the non-appearance of person entitled to the gratuity. Accordingly, in such cases, the gratuity order is revalidated, if it is received in Accountant General, Andhra Pradesh, Hyderabad within one year. If Gratuity payment orders remained un-drawn are received after one year, the Gratuity Payment Orders are cancelled and fresh Gratuity Payment Orders are issued in this places.

3. Since, the validity period of Gratuity Payment Orders is for a short period of 6 months, in many cases, the Gratuity Payment Orders are returned to the Accountant General, Andhra Pradesh, Hyderabad for either revalidation. Some times, the Gratuity Payment Orders returned to the Accountant General, Andhra Pradesh, Hyderabad by the Treasury Officers are found lost during the transit and Accountant General has to issue fresh Gratuity Payment Orders after observing all formalities. Consequently much hardship is caused to the pensioners and in some cases where abnormal delay had occurred, the pensioners approach the APAT and other judicial authorities for redressal.

4. Government after careful examination of the suggestion of the Accountant General (A&E), Andhra Pradesh, Hyderabad, hereby issue the following amendment order to the existing S.R.92 (c), TR.16 under A.P. Treasury Code Vol.I.
