The attention of Commissioner and Director of Municipal Administration and
Director of State Audit is invited to the references cited.

2. They are informed that Government after careful examination of the matter hereby
order that:

i) In case of Municipal employees retired from service on or before 31-3-2009, the
pension sanctioned proceedings issued by the Municipal
Commissioner/Commissioner and Director of Municipal Administration in
respect of the retired municipal employees itself be treated as Pension Payment
Order (PPO), subject to the condition that pensionary benefits admissible to the
employees were certified by the concerned District Audit Officer of State Audit,
and

ii) In case of Municipal employees retiring/retired from service on or after 01-04-
2009, the Municipal Commissioner/Commissioner and Director of Municipal
Administration as the case may be shall send the pension papers along with
sanctioned proceedings including Service Register (SR) after recording
necessary entries of retirement benefits to the concerned District Audit Officer
of State Audit for verification. The District Audit Officer of State Audit will issue
necessary authorization ie., Pension Payment Order (PPO)/ Gratuity Payment
Order (GPO) etc., to the District Treasury Officer concerned for payment of
pensionary benefits.

3. The Commissioner and Director of Municipal Administration/Director of State Audit,
Hyderabad shall take further necessary action accordingly under intimation to Government.
