ORDER:

In the reference 1st read above, orders were issued as a part of administrative reforms and decentralizing the powers delegating all administrative sanction powers to the concerned Special Chief Secretaries/Principal Secretaries/ Secretaries of the administrative departments of Secretariat for sanction of the Pensioner/Family Pensioner in so far as sanction of arrears of undrawn pension and family pension duly verifying the rule position envisaged in S.R.86 (b), 87 (a) under T.R.16 of Telangana Treasury Code Volume-I read with Article 55 of Telangana Financial Code Volume-I.

- 2. In the reference 2nd read above, orders were issued for certain amendments to SR 86 (b), SR 89 (a) and 89 (b) of T.R 16 under Telangana Treasury Code, Volume-I.
- 3. The Principal Accountant General (A&E), Telangana, Hyderabad in the reference 3rd read above has requested for enhancing the Validity period of newly issued Pension Payment Orders from one year to three years.

4. Government after careful examination in the matter, hereby issue the following amendment order to the Existing Instruction 60 of TR 16 under Telangana Treasury Code, Volume-I.

When a pensioner has failed to receive his pension for one year the Disbursing Officer should made enquiries through the District Police, as to the cause of his non-appearing stating clearly where the pensioner was residing, and the pension should not be paid till the enquiry is completed and the payment of pension shall be continued if no objection is found as a result of the enquiry.	When a pensioner has failed to receive his pension for three years as the case may be, the Disbursing Officer should made enquiries through the District Police, as to the cause of his/her non-appearing stating clearly where the pensioner was residing, and the pension should not be paid till the enquiry is completed and the payment of pension shall be continued if no objection is found as a result of the enquiry.
