**ORDER:-**

In the G.O.1<sup>st</sup> read above the Provision in Point No.6 i.e., **Preparation and Passing of Bills** shall be substituted as follows:

“The monthly pay bills of the Provincialised staff shall be prepared by the concerned Drawing Officers strictly as per the approved cadre strength. State Audit Department should scrutinize original order sanctioning the post. Whether the authority who sanctioned is competent to sanction the post and the process of recruitment is as per the rules in force. If any of the above conditions are not fulfilled those cases will not be recommended for payment of salaries through the treasury. The above process of verification of cadre strength by State Audit Department is one time exercise and after initial verification and first bill admittance by the Treasury on par with Zilla Parishads & Mandal Parishads provincialised employees.

The schedules for submission of Bills as applicable to the other Government servants will also hold good for provincialised employees.

The Commissioner of PR&RE AP Hyderabad is directed to take further necessary action in the matter.
