**ORDER:**

1. e-Panchayat Mission Mode Project[MMP] is one of the approved Mission Mode Projects under the National e-Governance Plan introduced by the Ministry of Panchayatraj, Government of India. It aims at internal computerization of Panchayats for effective use of Information Technology in various activities viz. Planning, Budgeting, Accounting etc. and in extending Citizen Centric Services to the rural populace. During the meeting held on 21.07.2012 certain decisions were taken for successful implementation of e.panchayat Mission Mode Project on computerization of Panchayat Raj Intuitions. Computers are to be provided initially to all the Head Quarter Cluster Gram Panchayats and the facility will be extended to all Mandal Praja Parishad, Divisional Panchayat Office, District Panchayat Office, Zilla Praja Parishad and Commissioner Panchayat Raj offices.

2. The Commissioner, Panchayat Raj & Rural Employment in his letter read above has informed that the Request for Proposal [RFP] is at final stage. For successful implementation and day to day monitoring of the e.panchayat programme, a State Level "Project Monitoring Unit" is required with infrastructure, man power and budget allocation for Rs.79,12,000/-. He has therefore requested to accord permission for establishment of Project Monitoring Unit in his office to monitor the e.panchayat Mission Mode Project programme at state level.

3. In the circumstances explained by the Commissioner, Panchayat Raj & Rural Employment, Andhra Pradesh, Hyderabad and after careful examination of the matter, Government hereby accord permission to the Commissioner, Panchayat Raj & Rural Employment, Andhra Pradesh, Hyderabad to establish Project Monitoring Unit at his Office and to incur an expenditure of Rs.79,12,000/- [Seventy nine lakhs twelve thousands rupees only] out of the e-panchayat grants available in his office.

4. The Commissioner, Panchayat Raj & Rural Employment, Andhra Pradesh, Hyderabad shall take further action in the matter accordingly.
