ORDER :-

In the reference 3<sup>rd</sup> read above, the Accountant General, A.P. Hyderabad had furnished a list of in operative Deposit Accounts and suggested for closure of such accounts as they have remained without transactions for more than three years.

2. In the reference 4<sup>th</sup> read above, instructions have been issued to the Director of Treasuries and Accounts, A.P. Hyderabad for lapsing the amounts in certain PD. Accounts which are in operative for more than three years and it was also ordered to lapse the balances under those PD Accounts and transfer the same to the consolidated fund under relevant head of account.

3. The Study Team constituted vide reference 5<sup>th</sup> read above, have examined the issue and noticed that most of the deposit heads mentioned by Accountant General are redundant, no longer available either in the D.T.O. records or could find a place in public account.

4. Government after careful examination of the issue hereby order for closure of the inoperative PD Accounts along with the closing balances as Annexed to this order.
