O R D E R :

In the reference 1st read above the Government of India have requested all States to constitute Monitoring Committees at State Level to resolve issues related to Model Accounting System for Panchayats [MAS] and PRIA Soft and the Model Accounting System is mandatory for the States to become eligible for receiving Performance Grants of the 13th Finance Commission grants for Local Bodies. The Minister of Panchayat Raj has already launched PRIA Soft that captures details of receipts and expenditure based on vouchers and generates cash books, reports, registers and MIS etc. In order to adopt PRIA Soft, the Minister of Panchayat Raj plans to bring out a Panchayat Accounts Manual and a Training Manual on Model Accounting System /PRIA Soft and also requested the States to constitute Model Accounting System Committees at the Central and State Government Levels to ensure expeditious implementation of Model Accounting System /PRIA Soft, to resolve queries of the implementing Entities/Authorities and other related matters like composition of Central Model Accounting System Committee [CMC]. The Minister of Panchayat Raj has also suggested a list of officers who are to be included in the Committee. The Commissioner, Panchayat Raj & Rural Employment, vide ref.2nd read above has requested the Government to issue orders for constitution of the State Model Accounting System Committee [SMC] as suggested by the Government of India.

2. Accordingly, the Government, after due consideration of the matter, hereby constitute the "State Model Accounting System Committee [SMC]" with the following officers:
