**ORDER:**

In the G.O. 1<sup>st</sup> read above, orders have been issued that 15% of the General Revenues of the Zilla Praja Parishads and Mandal Praja Parishads be earmarked for Women and Child Welfare activities and the schemes for which 15% of the General Revenues of Zilla Praja Parishads and Mandal Praja Parishads can be utilized have also been indicated.

2. In the G.O. 2<sup>nd</sup> read above, revised orders have been issued clearly indicating the areas of activity of the Zilla Praja Parishads and Mandal Praja Parishads for effective utilization of the 15% earmarked funds.

3. It has been brought to the notice of the Government by certain Collectors that 15% Zilla Praja Parishads funds like the Mandal Praja Parishads funds need to be utilized for construction of Anganwadi Centres as many of these centres are in rented buildings where minimum facilities such as drinking water and toilets are not available.

4. After consideration of the above, Government hereby order that all areas of activities permissible with earmarked funds of Mandal Praja Parishads vide G.O. 2<sup>nd</sup> read above including construction of Anganwadi Centres will also be permissible with earmarked funds of Zilla Praja Parishads as far as Women and Child Welfare activities are concerned.

5. This order issues with the concurrence of Panchayat Raj and Rural Development Department vide their C.No.3654/PrI.Secy,PR/2012, dt.07-05-2012.
