ORDER:-

The following Notification shall be published in the Extra-Ordinary issue of the Andhra Pradesh Gazette dated the 12.12.2012.

2. In G.O.Ms.No.154, Industries and Commerce (Mines-I) Department, dated 15-11-2012, rule 9(B) to 9(Z) of Andhra Pradesh Minor Mineral concession rules 1966 was amended and substituted by Rule 9(B) to 9(T) for Regulation of extraction/disposal of River sand in the State and accordingly the Governor of Andhra Pradesh in exercise of powers conferred under sub-section(1) of section 15 of the Mines and Minerals Development and Regulation Act, 1957, Notified the amendments in Andhra Pradesh Gazette Notification No.38A, dated 15-11-2012.

NOTIFICATION

In exercise of powers conferred by sub Rule (1) of Rule 9-Q of Andhra Pradesh Minor Mineral Concession Rules, 1966 the Governor of Andhra Pradesh here by authorizes the Tahsildar (or) the Officers nominated by Tahsildar at Mandal level: the Sub Collector/Revenue Divisional Officer (or) the Officers nominated by Sub Collector/Revenue Divisional Officer at Divisional level: the Joint Collector/the District Collector (or) the Officers nominate by the Joint Collector/the District Collector at District level to be the Officers to confiscate any machinery/vehicle that has been used for extraction and transportation of sand in contravention to these rules.

2. The District Collector shall cause publication in District Gazette the above mentioned Officers or their nominees to exercise the powers

to confiscate and machinery/vehicle that has been used for extraction and transportation of sand in contravention to these rules through notification from time to time.
