O R D E R :

Backward Region Grant Fund is designed to redress regional imbalances in development. The fund will provide financial resources for supplementing and converging in the existing developmental inflows so as to bridge critical gaps in local infrastructure, strengthen the local governance in Capacity Building, professional support to local bodies for planning, implementation and monitoring the plans and improve the performance and delivery of critical functions assigned to Local Bodies.

2. In the reference read above, the Commissioner, PR & RE, Hyderabad has submitted detailed proposals duly working out the functions and composition of Project Monitoring Unit at the State and District Level under BRGF Programme and also its financial implications to the Government for consideration.

3. Government have felt that in order to ensure proper implementation of Backward Regions Grant Fund Programme and follow up with the Government of India for timely release of funds etc., it is very essential that a PMU be created at the State Level to start with.

Government after careful examination of the proposals submitted by the Commissioner, PR & RE, Hyderabad in the reference read above, hereby accord permission for the following posts carrying the remuneration as indicated hereunder for the purpose of creation of PMU at State Level Under BRGF Programme.

Rama Krishna, IAS (Retd) as Senior Consultant at Project Monitoring Unit at State Level under BRGF Programme with a remuneration of Rs.50,000/- per month on adhoc basis. Further Government direct that the rest of the supporting staff shall be recruited strictly on outsourcing basis.

6. The expenditure for all the above posts as well as other items like stationery, hiring of vehicles, building rent etc, shall be met from the 5% Development Grant from BRGF releases.

8. The Commissioner, PR & RE, Hyderabad shall take further action in the matter accordingly.
