ORDER:

- 3. In the reference 8th read above, Government have accepted the recommendations of Group of Ministers, in which one of the demands relates to enhancing of honorarium to Sarpanches of Major and Minor Gram Panchayats.

6.	Sitting fee of Mandal Parishad Members	Rs.50/-	Rs.100/-
7.	Sitting fee of Zilla Parishad Members	Rs.75/-	Rs.150/-
