ORDER:-

In the G.O.1<sup>st</sup> read above, the Government have delegated the powers for conducting pre delivery quality control inspection of 100% of materials to the concerned field Engineers for inspection and certification.

2. In the G.O. 2<sup>nd</sup> read above, Government have issued certain amendments with regard to delegation of powers for conducting pre-delivery quality control inspection and issue of certification of materials for TDWSP/ RWSS works in order to speed up the TDWSP/ RWSS works, along with V&QC staff, WAPCO's and Technical Person & Executive Agencies.

3. In reference 3<sup>rd</sup> read above, the Engineer-in-Chief, RWS&S, Hyderabad has stated that as most of the manufacturing units of all materials required (except HDPE and PVC pipes) for Intra Village works under Mission Bhagiratha are located out of State i.e. located in Gujarat, West Bengal and Punjab and due to time requirement and huge work load, he has requested the Government to make certain amendments to the G. O. RT. No. 789 of PR & RD (RWS-IV) Dept., dated: 31.12.2015 for further delegating the powers for conducting Pre-Delivery Quality Control Inspections and certification of materials for Intra Village works under Mission Bhagiratha.

4. Govt., after careful examination of the proposal, hereby make the following amendment to G.O.2<sup>nd</sup> read above in respect of pre-delivery QC inspection of materials and issue of QC Certificates.

TDWSP Intake &amp; transmission works:</b></p> <p><b>1.</b> SE/ EE TDWSP or field engineer authorized by SE, TDWSP concerned shall conduct pre-delivery quality control inspection of all materials invariably along with one official i.e., EE/ DEE/ AEE from V&amp;QC wing &amp; one authorized qualified person from WAPCO's along with one qualified representative of the contracting agency duly following the relevant BIS Codes and their amendments from time to time and also as per agreement conditions stipulated therein and issue immediate clearance for dispatch on the same day of inspection subject to satisfying the requirement as stated above.</p>

<p>2. The Quality Control certificates shall be issued by the SE, TDWSP concerned within three working days from the date of inspection. The files concerned and QC certificate registers shall be maintained properly in the TDWSP offices and copy of the QC certificate shall be submitted same day invariably to the CE, Vig / CE, TDWSP and E-in-C (RWS&amp;S) for record purpose and weekly basis review has to be done by the CE, Vig.</p>	<p>2. The Quality Control certificates shall be issued by the SE, TDWSP concerned within three working days from the date of inspection. The files concerned and QC certificate registers shall be maintained properly in the TDWSP offices and copy of the QC certificate shall be submitted same day invariably to the CE, Vig / CE, TDWSP and E-in-C (RWS&amp;S) for record purpose and weekly basis review has to be done by the CE, Vig.</p>

The Chief Engineer, TDWSP concerned shall randomly conduct 10% of the pre-delivery quality control inspection of materials in each segment along with the above officials and the concerned SE will issue a Quality control certificate to that extent as the complete record is available at district level.</p>	<p>3. The Chief Engineer, TDWSP concerned shall randomly conduct 10% of the pre-delivery quality control inspection of materials in each segment and Electro-Mechanical equipments/ items and valves of above 600mm dia along with the above officials and the concerned SE will issue quality control certificate to that extent as the complete record is available at district level.</p>

The Chief Engineer, TDWSP concerned shall conduct a pre-delivery quality control inspection of all materials pertaining to Electro-Mechanical equipments/ items and valves of above 600mm dia.</p>	<p>4. The Chief Engineer, TDWSP concerned shall conduct a pre-delivery quality control inspection of all materials pertaining to Electro-Mechanical equipments/ items and valves of above 600mm dia.</p>
<p><b>B. For Regular RWS&amp;S MVS works &amp; TDWSP Intra Village System works:</b></p> <p>1. The SE/ EE, RWS&amp;S concerned shall conduct pre-delivery quality control inspection of all materials except pertaining to Electro-Mechanical works and valves with more than 600mm dia invariably along with one official i.e., EE/ DEE/ AEE from V&amp;QC wing &amp; one qualified representative of the contracting agency duly following the relevant BIS codes and their amendments from time to time and also as per agreement conditions stipulated therein and immediately issue clearance for dispatch on the same day of inspection subject to satisfying the requirement as stated above. For Intra Village system works, one authorized qualified person from WAPCOS should also accompany the above officials for conducting pre-delivery quality control inspection of all materials.</p>	<p><b>B. For Regular RWS&amp;S/MVS works and TDWSP-Intra Village works:</b></p> <p>1. The V&amp;QC officials shall conduct Pre-delivery quality control inspection of materials like Pipes, Valves, OHSR Specials, Taps and appurtances etc. duly following the relevant BIS codes and their amendments from time to time and also as per agreement conditions stipulated therein and immediately issue clearance for dispatch on the same day of inspection subject to satisfying the requirement as stated above.</p>
<p>2. The Quality Control Certificates shall be issued by the SE, RWS&amp;S concerned within three working days from the date of inspection. The files concerned and QC certificate registers shall be maintained properly in the RWS&amp;S offices and copy of the QC Certificate shall be submitted invariably to the CE, Vig/ CE, RWS&amp;S concerned and the E-in-C (RWS&amp;S) for record purpose on weekly basis.</p> <p>3. The chief Engineer, RWS&amp;S concerned shall randomly conduct 10% of the pre-delivery quality control inspection of materials (a) in each district for Regular RWS&amp;S MVS works which costs more than Rs. 5.00 Crores and (b) in each package for TDWSP Intra Village System works along with the above officials and the concerned SE will issue a Quality Control Certificate to that extent.</p> <p>4. The Chief Engineer, RWS&amp;S concerned shall conduct pre-delivery quality control inspection of all materials pertaining to Electro-Mechanical works and Valves with more than 600mm dia.</p>	<p>2. The Quality Control Certificates shall be issued by Engineer-in-Chief, RWS&amp;S or his authorized officer within three working days from the date of inspection.</p>
