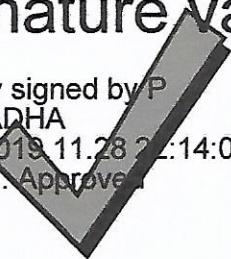

The attention of the Metropolitan Commissioner, Hyderabad Metropolitan Development Authority/Commissioner, Greater Hyderabad Municipal Corporation / Vice Chairman, Kakatiya Urban Development Authority / Director of Town and Country Planning/ Commissioners of all ULBs is invited to the subject and references cited.

2. In the reference 4th cited orders were issued to dispose all pending LRS applications by **31.10.2018**. Now it has come to notice of the Government that few more LRS applications are still pending, mostly in HMDA area for various reasons i.e., for want of NOC from Revenue / Irrigation Authorities with regard to title aspects, payment of balance LRS charges etc.,

3 Therefore, after careful consideration of the matter Government hereby extend the time limit upto **31-12-2019** for disposal of pending LRS applications in the following cases only.

- (i) LRS applications which were received on or before the cutoff date of 31-12-2016 (i.e., last date prescribed earlier for receipt of LRS applications.)
- (ii) Where the balance LRS amount / required documents are due from the applicants.
- (iii) Where NOC is pending from other Departments like Revenue / Irrigation Department etc.

4. In respect of LRS applications which are pending for want of NOC from Revenue / Irrigation Authorities with regard to title aspects etc., the Planning Staff of HMDA / UDAs/ULBs shall pursue with the Revenue / Irrigation Authorities and shall dispose all pending LRS applications by **31.12.2019**.

5. The Commissioner, Greater Hyderabad Municipal Corporation / Metropolitan Commissioner, Hyderabad Metropolitan Development Authority / Vice Chairman Kakatiya Urban Development Authority and other UDAs / Director of Town and Country Planning/ Commissioners of all ULBs are directed to take further action accordingly and ensure that all pending LRS applications are disposed in a time bound manner by **31.12.2019**.
