It is to inform that General Administration (V&E) Dept., Govt. of Telangana vide ref 1st cited , it was instructed to all concerned Engineering departments to deduct 1% Labour cess directly from the Contractor without adding the same in the bills. Accordingly vide ref 2nd cited, all the Superintending Engineers (PH), Executive Engineers (PH), Commissioners of all ULBs were instructed not to provide 1% labour cess in the estimates and recover 1% labour cess from the contractors with the effect from 27.08.2011.

The Board of Chief Engineers vide ref 3rd cited decided to incorporate a separate provision in the estimate @1% towards labour cess in Part-B of the estimate in all the Engineering works of Government of Telangana in respect of all future works.

In the view of the above, all the Superintending Engineers (PH) and Executive Engineers (PH) are requested to provide a provision of Labour cess in the estimate @ 1% on ECV and the remittance of the Labour cess @ 1% on the value of work to the Labour welfare Department by **directly deducting the same from the bills of Contractor without addition OR from the provision**

made in the estimate as per General Administration (V&E) Dept., Govt. of Telangana instructions and without deducting from the bills of the contractor will however be **subject to final orders of the Government** in the matter. They are also requested to inform the same to all ULBs under their jurisdiction to follow the same.
