**NOTIFICATION**

In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the Government of Telangana hereby makes the following amendment to the Greater Hyderabad Municipal Corporation Act, 1955.

**AMENDMENT**

In the said Act, in Section 5 in sub-section (1-A), the following shall be omitted:

“as on the date of filing of nomination for becoming Member of Legislative Council or on the date of nomination by the Governor, as the case may be”
