The attention of the Municipal Commissioners of all Urban Local Bodies of the State except GHMC is invited to the references cited. In the reference 1st cited, Government issued comprehensive guidelines for according permission for installation of new Tele Communication Infrastructure Towers which includes Cell Phone Towers/ Ground Based Towers/ Roof Top Towers/ Roof Top Poles / Antenna Fixtures/ Fabricated Antenna/ Towers for installation of Telephone lines/ Transmission towers duly prescribing certain permit fee and charges.

- 2. In the reference 2nd cited, Government informed that as per Clause-D of guidelines issued in G.O.Ms.No. 380 MA & UD Department, dt. 01.08.2013, sanctioning authority shall issue or refuse permission not later than 30 days from the date of receipt of application and in case of refusal, the reasons for the same shall be clearly mentioned and if no permission or refusal is accorded within 30 days, the permit is deemed to have been accorded, provided that the said installation shall comply with all the guidelines.
- 3. Government further informed that, it has come to their notice that permissions are not being given in the stipulated period of 30 days and ultimately delaying erection of communication towers and therefore directed the Commissioners of all Municipal Corporations, Municipalities and Nagar Panchayats to dispose the applications within the stipulated period of 30 days, otherwise the applicants will proceed further under deemed clause and the officers concerned will be held responsible for the delay. - 4. In view of the above, the Municipal Commissioners of all the Urban Local Bodies of the State (except GHMC) are directed to furnish information on the number of

applications received for erection of Cell Phone Towers/ Ground Based Towers/ Roof Top Towers/ Roof Top Poles etc. nos. permitted, nos. rejected, nos. under process including reasons thereof along with permit fee and charges in terms of G.O.Ms.No. 380 MA & UD Department, dt. 01.08.2013 in the prescribed proforma enclosed immediately to the RDMA concerned who in turn shall compile and submit consolidated report to this office by 23.05.2015 without fail.
