Sub: MA Department – Dispensing with approval of the District Level Committees for works proposed by ULBs under Pattana Pragathi State matching grants and 14th Finance Commission Grants-Vesting sanctioning powers to Municipal Councils / Corporations-Revised Orders-Issued- Reg.

Ref: GO.Rt.No.523, MA&UD(UBS) Deptt., Dt:16/10/2020.

I invite your attention to the reference cited(copy enclosed) wherein Government have issued orders in supersession of GO.Rt.No.196, MA&UD(UBS) Deptt., Dt:13/05/2020, according permission to Municipal Councils/Corporations to sanction the works relating to State Matching Grant and 14th Finance Commission Grant released under Pattana Pragathi programme.

2. The following are admissible works to be taken up under Pattana Pragathi programme:

- a. Sanitation (Purchase of vehicles, purchase of PPE, repairs to sanitation vehicles, IEC, Pattana Pragathi Sanitation Drives, Hire charges of JCB for sanitation, de- siltation of drains, DRCCs , Transfer stations etc.)
- b. Development of Nurseries- Greenery Development under Haritha haram
- c. Development of Crematoriums vaikuntadhamams
- d. Development of Integrated markets
- e. Development of Parks and Playgrounds, Gyms
- f. Construction/maintenance of Public Toilets
- g. Development of Auto Stands/ Rickshaw stands
- h. Development of Dump site,
- i. Construction & maintenance of MSWM Processing plants (incl Composting and their sheds) and Bio- mining of legacy waste.
- j. Management of Construction & Demolition waste

- k. Construction and maintenance of FSTPs (also Public Toilets etc)
- l. Development of Street Vending zones/ Shelters for homeless m Extension of street lights to uncovered areas/ dark spots
- n. Remunerative enterprises which earns income to ULBs.
- o. Main Roads development
- p. Storm Water Drains.
- q. Development of Medians & Footpaths and
- r. Payment of C.C. charges
- s. Any item of work other than the above shall be submitted to the District Collector concerned for according approval.

3. Further, it is also mentioned that the works taken up under any scheme for which funds are not released till date and works are ongoing, which are permissible items mentioned above, the Pattana Pragathi funds shall be utilized for the said works. Further the works of above admissible items taken up prior to Pattana Pragathi programme shall also be paid from the Pattana Pragathi funds.

3.1. The Accounts personnel working in the Municipalities are informed to book expenditure against the above components under Pattana Pragathi grants immediately and utilise the grants released to the Municipality immediately. Like wise while uploading the cheques on IFMS portal the nature of expenditure shall be specifically mentioned as " Pattana Pragathi" so that the same shall be passed immediately by the finance department. They shall also ensure that once the M-Book are received from Engineering section, they shall not be delayed under any circumstances.

3.2. The Engineers working in the Municipalities are also instructed to complete the work as per time lines and record the measurements immediately without any delay and send the same for payment. Any un-necessary delay in either recording the works or payment for completed works shall be viewed serious.

4. In view of the above, while forwarding a copy of the reference cited, I request all Municipal Commissioners of ULBs in the State to take necessary action in the matter as per the orders issued by the Government. The details of works pending under various schemes shall be submitted to this office in the enclosed format immediately.
