Sub: Mpl Admn Dept- Municipal Solid Waste- Municipalities/Corporations operating the slaughter houses without consent of the Board under Water (P&C of P) Act, 1974 and Air(P&C of P) Act, 1981-Writ Petition (civil) no.309 of 2003, filed in Hon'ble High Supreme Court of India on issues relating to slaughter houses-Certain instructions issued-Reg

The attention of Commissioners of Municipal Corporations and Municipalities/Nagarpanchayat is invited to the reference 2nd cited, wherein instructions were issued to implement the directions issued by the Hon'ble Supreme Court of India in W.P.No.309 of 2003 in letter and spirit and also directed to provide necessary infrastructure for provision of Effluent Treatment Plant and to dispose the solid waste as per the Municipal Solid Waste (Management & Handling) Rules, 2000. They are also informed in the reference 2nd cited that any omission and commission noticed in implementation of the above Rules, the concerned will be held personally responsible and further action as deemed fit will be initiated against the defaulters for non-implementation of the above Rules.

2. The attention of the Commissioners of Municipal Corporations and Municipalities/Nagarpanchayat is invited to the reference 4th cited (copy enclosed for ready reference), wherein Government were pleased to issue orders constituting Committees at State Level, District Level, Divisional Level and Municipal Corporation level for effective management of Slaughter houses by the Government of Telangana. In the above order Government have also defined the functions of the above Committees. Therefore, the District Head Quarters Municipal Commissioners, the Divisional Head Quarters Municipal Commissioners of Municipalities are directed to take immediate action to convene the meeting of District Level and Divisional Level Committees every month in consultation with Joint Collector, RDO/Sub-Collector respectively and review the functions as defined in para 7 of the reference 4th cited and submit action taken reports to the District Collector, to this office and to Government before the 10th of every month. The Chief Veterinary Officer/Veterinary Officers of Municipal Corporations of Warangal, Khammam, Nizamabad, Karimnagar and Ramagundam and Commissioners of Municipal Corporations are also directed to convene the meetings of Municipal Corporation Level Committee every month and review the functions as defined in para (7) of the reference 4th cited and submit action taken reports to the District Collector, to this office and to

Government before the 10th of every month. Any failure in implementing the instructions issued by the Government in the reference 4th cited, the Municipal Commissioners of District Head Quarters/Divisional Head Quarters Municipalities and the Commissioners of Municipal Corporations and also the Municipal Commissioners of all ULBs will be personally held responsible.

3. All the Municipal Commissioners of ULBs are informed that in the reference 3rd cited, the Member Secretary, TSPCB has stated that the Pollution Control Board already issued directions to the Municipal Slaughter Houses for operating without obtaining CFE/CFO of the Board, not treating the effluents and not disposing the solid waste as per the MSW Rules, 2000 and requested this office to issue necessary directions to all the Commissioners of ULBs to apply for consent of the board for the slaughter houses after providing effluent treatment plants for treating the effluents, facilities for composting of wet solid waste.

4. In the reference cited, the Member Secretary, Telangana State Pollution Control Board has informed that most of the Municipalities are operating slaughter houses without Consent of the Board, by not providing Effluent Treatment Plants (ETPs) and not connecting their waste water outlets to the Sewage Treatment Plants and observed that the Municipalities are not complying with the disposal of the solid waste generated from the slaughter houses as per the Municipal Solid Waste (Management & Handling) Rules, 2000. He has also informed that operating slaughter houses without consent of the board is violation under Section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 & Section 21/22 of the Air (Prevention and Control of Pollution) Act, 1981 and amendment thereon.

5. Therefore, all the Commissioners of ULBs are directed to apply for the consent of the Pollution Control Board for the slaughter houses after providing Effluent Treatment Plants (ETPs) for treating the effluents, facilities for composting of wet solid wastes.

6. The Regional Director - cum - Appellate Commissioners of Municipal Administration, Hyderabad and Warangal are requested to review this matter during their monthly review meetings and ensure that all the ULBs shall implement the Municipal Solid Waste (Management & Handling) Rules, 2000 while Slaughtering of Animals at Slaughter Houses.

7. All the Commissioners of ULBs are directed to submit a compliance report on the issues to this office for onward transmission to the Government.
