The attention of all the Commissioners of the Corporations and Municipalities in the address entry is invited to the references cited, wherein, as envisioned by the Hon'ble Chief Minister of Telangana to achieve greater energy efficiency in urban local bodies, the following 12 ULBs were selected for replacement of existing street lights with energy efficient LEDs on pilot basis in selected stretches through M/s Energy Efficiency Services Ltd (A Joint Venture of PSUs of Ministry of Power – Govt. of India).

- 1) Karimnagar Corpn,
- 2) Nizamabad Corpn
- 3) Gajwel Nagara Panchayat
- 4) Siddipet Municipality
- 5) Siricilla Municipality
- 6) Ramagundem Corpn
- 7) Khammam Corpn
- 8) Mahboobnagar Municipality
- 9) Manchiryal Municipality

- 10) Nalgonda Municipality
- 11) Tandur Municipality
- 12) Warangal Corporation.

2. In this connection, to discuss on the proposal furnished by the EESL on the above subject, a meeting was convened on 11.09.2014 at C&DMA office under the chairmanship of C&DMA along with E-in-C(PH) with M/s EESL and Mayors, Chairpersons, Municipal Commissioners and Engineers of 12 ULBs, in which detailed deliberations were taken place on pilot study, and ULBs have expressed their satisfaction and agreed to extend full cooperation to make the project a grand success, vide reference 9th cited above.

3. In the reference 10th cited, Government have approved the EESL proposal and permitted the C&DMA to take up the street lighting pilot study in selected stretches of 12 ULBs of the State with M/s EESL, New Delhi as per the terms and conditions mentioned therein.

4. In this connection, the Municipal Commissioners of 12 selected ULBs are requested to discuss the pilot project (replacement of existing conventional street lights with energy efficient street lights (LEDs) in the already furnished selected stretches) in the Standing Committee/ Council meeting, and pass a resolution on the following points and furnish to this office by 20th September 2014, to take further necessary action in the matter;

- i. Hand over selected stretches to the EESL for the entire agreement period
- ii. Ensure 100% Electrical Meters in working condition in selected stretches to measure the accurate energy consumption, and replacement damaged cables and junctions boxes if any with immediate effect.
- iii. Ensure 100% glowing of lights in the selected stretches, so as to arrive at accurate energy consumption in that area before replacement with LEDs
- iv. Extend cooperation with EESL in planning, operation and maintenance during the project period
- v. ULB shall pay the monthly electricity bill to the escrow accounts to be opened separately during the agreement period for selected stretches only.
- vi. ULB shall nominate the Electrical Engineer/DE/AE concerned as liaison officer for the pilot project
- vii. ULB shall maintain separate record for the selected stretch, i.e., No.of lights, fixtures, load factor, Meter Nos., Metering readings, bills of last one year prior to project to till the end of the agreement period etc.
