Whereas the Greater Hyderabad Municipal Corporation Act, 1955 (Telangana Adaptation Orders) 2015, to the State of Telangana has been adopted to the State of Telangana vide Notification issued in the G.O. second read above and subsequently amended in the G.O. third read above.

2. And whereas, the Commissioner & Special Officer, Greater Hyderabad Municipal Corporation, Hyderabad for the reasons explained in the letter fourth read above, requested for certain amendment to the principal Act;

3. And whereas, after examining the issue, it has been decided to amend section 40 of the Greater Hyderabad Municipal Corporation Act, 1955 suitably;

4. Accordingly, the following Notification will be published in an Extraordinary issue of the Telangana Gazette dated: 06.01.2016.

NOTIFICATION

In exercise of the powers conferred by section 101 of the Andhra Pradesh Re-organisation Act, 2014 (Central Act No.6 of 2014), the Government of Telangana hereby makes the following amendment to the Greater Hyderabad Municipal Corporation Act, 1955.

AMENDMENT

In the said Act, the proviso to sub-section (1) of section 40 shall be omitted.
