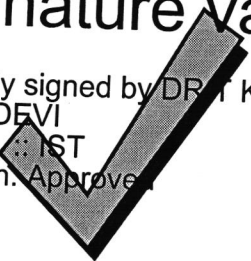

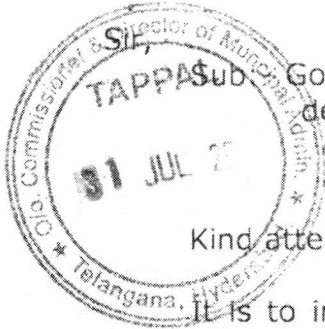

Goods and Service Tax – Remittance of TDS amounts already deducted – Request – Regarding.

Kind attention is invited to the subject cited.

It is to inform that Goods and Service Tax has been implemented from 01.07.2017. In this context it is requested that all TDS amounts deducted by the concerned Departments may kindly be remitted before 31.07.2017 lest the amounts reported after 01.08.2017 shall become part of the total revenue of the State and it may likely to reduce the compensation amount to be received from Government of India. The Government of India has assured compensation for 5 years post implementation of GST in case of fall in revenue.

Therefore, it is once again requested to direct the concerned to immediately remit all the TDS amounts to the Commercial Taxes Department before 31.07.2017
