Sub: CDMA, TS, Hyd – Allocation of funds under SCSP & TSP for the FY 2017-18 – Furnishing of action plans – Requested - reg.
Ref: G.O.Rt.No.917, Finance (DCM)Dept., dt:15.05.2017.

I invite your attention to the subject, and reference cited, and inform that the Government have provided B.E.2017-18 of Rs.301.88 crores under General Head, Rs.61.80 crores and Rs.36.32 crores under SCSP & TSP totalling to Rs.400.00 crores to the Municipal Corporations of Khammam, Karimnagar, Nizamabad & Ramagundam under the Head "2217-80-789-796-25-91-310-312" and Rs.226.41 crores under General, Rs.46.35 crores for SCSP and Rs.27.24 crores under TSP totalling to Rs.300.00 crores to the Greater Warangal Corporation under the Head "2217-80-789-796-25-90-310-312" in the F.Y 2017-18.


In this connection, the following instructions are issued for strict compliance.

1. The works under SCSP/TSP shall be identified in the localities where the population of SCs/STs is more than 40% in the descending order.
2. The approval of the Municipal council for the works identified shall be obtained, if necessary by convening urgent meeting.
3. Necessary technical approvals shall be obtained from the competent authorities.
4. Tenders shall be invited as early as possible.
5. The identified works need not be sent to this office for administrative sanction.
6. No administrative sanction from the council shall be obtained over and above the allocation.
7. Any deviation to the above instructions will be viewed seriously.
8. The tentative allocation under SCSP/TSP is once again enclosed and proposals may be restricted to the extent of allocations only.
9. The information in the prescribed Performa shall be furnished to this office by 05.08.2017 without fail.

Further, I am to inform that works can be proposed under roads, drains, water supply, community halls and other infrastructure facilities under each category i.e., General, SCSP & TSP as mentioned in the Annexure. The above proposals shall be submitted to this office strictly as per the allocations with the approval of municipal council by 05.08.2017 without fail so as to enable to submit the same to the Government and concerned welfare Departments.
