Sub:- M.A.Dept. – Adoption of Sanitation Workers Group (SWG) System of Greater Hyderabad Municipal Corporation to Urban Local Bodies in the state in place of Outsourced Contract System to improve the work efficiency – Permission accorded – Lack of implementation noticed – Reiterating Instructions – Reg.

The attention of the Commissioners of all the Urban Local Bodies in the State are invited to the references cited, wherein in the reference 1st cited Government have issued accorded permission for adoption of Sanitation Workers Group (SWG) System of Greater Hyderabad Municipal Corporation to Urban Local Bodies in the state in place of Outsourced Contract System as recommended by the State Level Advisory Board (SLAB) to improve the work efficiency.

2. Accordingly, in the reference 2nd & 3rd the said Government Orders was communicated to all the Urban Local Bodies in the State and instructions were issued not to call for fresh tenders for the employees under out sourcing system and to take action for engaging of the workers duly forming the Sanitation Workers Group (SWG) as per the guidelines defined by the Government which is enclosed to the G.O.

3. In this regard, as per the latest report obtained from the all the Urban Local Bodies in the State, it is noticed that, some Urban Local Bodies are under the process of registration, some are paying wages through TLFs/Mahila Sanghalu, some are pending for Council Resolution, some are not yet finalised the workers groups which shows that there is slackness in implementation of Government Orders & instructions issued by the higher authority.

4. Therefore, all the Commissioners of the Urban Local Bodies in the State are once again instructed that, there will not be any exemption in implementation of Government orders for adoption of Sanitation Workers Group (SWG) System in Urban Local Bodies in the state in place of Outsourced Contract System and shall ensure strict compliance in the matter and any non-implementation of Sanitation Workers Group (SWG) System in Urban Local Bodies will be viewed seriously and further action against concerned will be initiated as deemed fit.
