Sub: Establishment - O/o C&DMA - Telangana, Hyderabad - Instructions to Municipal Commissioners of all ULBs in the State regarding the appointment on compassionate grounds to the dependents of deceased NMR's - Instructions - Issued - Reg.

All the Municipal commissioners of all the ULBs in the State of Telangana are requested to follow the check list given below while sending proposals for providing appointment on compassionate grounds to the dependents of deceased NMR's in their respective Municipalities as per the guidelines issued by the Government Vide G.O.Ms.No. 118, Finance & Planning (Fin Wing. PC.III) Dept., Dated: 18.08.1999 while processing the file for providing compassionate appointments to deceased NMR's dependents whose services are proposed for regularization and pending with Government. Further they are also directed to furnish the information in the following check list along with the proposals.

5	No of Vacancies and Reason for arised vacancy to regularize the deceased NMR Services. (Retirement/Transfer/Death)	
6	Seniority of the deceased NMR in the Seniority list of the NMR's to be regularized	
7	Date of representation of dependents of the deceased NMR's (whether regularization is proposed and pending with Govt) for compassionate appointment	

If any of the above mentioned conditions are not satisfied the Municipal Commissioners may issue a speaking orders rejecting the representation of the legal heirs of the deceased NMR while giving reason to that effect and obtain acknowledgement. Any contravention of the instructions mentioned above, stringent action will be initiated against the officers concerned.

In view of the above, the Municipal Commissioners of all ULBs are requested to examine the proposals received for providing compassionate appointment to deceased NMR's with reference to the above check list and shall take necessary action.
