Sub:- Advertisement Charges - Abnormal Expenditure incurred towards payment of advertisement charges - Certain objections raised by the Director of State Audit - Certain instructions - Issued.

Ref:- 1. This office Circular Roc.No. 10487/2008/N2, dt. 02.07.2008 addressed to all the Commissioners of ULBs
2. Lr.Roc.No. 8626/G1/2012-C, dt. 30.03.2012 of the Director of State Audit, Hyderabad

The attention of the Municipal Commissioners of all Urban Local Bodies in the State is invited to the reference 2nd cited wherein the Director of State Audit, Hyderabad has communicated a copy of CARR (Consolidated Audit and Review Report) on the Accounts of PRLs and ULBs for the year 2008-09. In the said report, it has been pointed out by the Director of State Audit, Hyderabad regarding the abnormal expenditure incurred by certain Municipalities during the year 2008-09 towards advertisement charges.

In the reference 1st cited, instructions were already issued to the Commissioners of all Urban Local Bodies in the State not to issue any advertisements without prior permission of the Government, since advertisements other than the tender notice come under extraordinary expenditure.

3. It is once again reiterated that, as per Section 130 of Andhra Pradesh Municipalities Act, 1965, prior permission of the Government or the higher authorities as the case may be has to be obtained for giving any Advertisements, other than the Tender Notices.

4. In view of the above, the Municipal Commissioners of all the ULBs in the State are instructed to strictly follow the rules and guidelines issued by the Government and this office from time to time on advertisement charges scrupulously or else suitable disciplinary action would be initiated against the erring officials.
