"Whenever the vacancies arise in the Last Grade Service including PH and Non-PH Workers and other equalling cadres in Urban Local Bodies, the concerned Municipal Commissioner shall notify the vacancies to the concerned District Employment Exchange through the District Collector, in turn by virtue of appointing authority the District Collector shall make a due process of selection and issue appointment orders to the selected candidates."

The Director of Municipal Administration, Telangana, Hyderabad shall take further necessary action in the matter accordingly.
